- 6. 5th amendment definition of self-incrimination, the Miranda decision and its aftermath
- 7. Due process concerns with identification procedures---lineups, showups, photo arrays
- 8. 6th amendment right to counsel, confrontation, jury trial requirements
- 9. 8th amendment issues of cruel and unusual punishment
- 10. The exclusionary rule
- 11. Trial procedure---decision to charge, preliminary hearings and grand juries, pretrial motions, jury selection, verdicts
- 12. Sentencing policy and the appellate process---direct attack and habeas corpus

### **D. LEARNING OUTCOMES (General)**

- 1. Students will learn and appreciate the role of criminal procedure in a criminal justice system to provide due process as a counterweight to state police power and crime control efforts.
- 2. Students will learn both the theoretical and practical applications of the protections afforded the criminally accused in the areas of searches, seizures, self-incrimination, right to counsel, jury trials and the appellate process.
- 3. Students will understand the consequences of the exclusionary rule and its limitations on criminal evidence production as well as collateral usage of otherwise excluded evidence.
- 4. Student shall understand theories of punishment and the sentencing process including sentencing guidelines regimes, alternative sentencing, and restorative justice as well as the criminal appellate process of both direct appeals and habeas corpus petitions, federal and state.
