- 11. Students will understand effective strategies to support client advocacy and influence public policy and government relation on local, state, and national levels to enhance equity, increase funding, and promote programs that affect the practice of clinical mental health counseling.
- 12. Students will analyze and use data to increase the effectiveness of clinical mental health counseling interventions and programs.
- 13. Students will apply relevant research findings to inform the practice of clinical mental health counseling.
- 14. Students will develop measurable outcomes for clinical mental health counseling programs, intervention and treatments.
- 15. Students will know evidence-based treatments and basic strategies for evaluating counseling outcomes in clinical mental health counseling.
