Students have the option to file a Special Conditions Appeal when his or her financial situation has significantly changed and 2019 tax information as reported on the 2021-2022 Free Application for Federal Student Aid (FAFSA) does not accurately reflect the current financial condition.

Required Documentation for All Appeals

- A completed 2021-2022 Free Application for Federal Student Aid
- A signed letter clearly explaining the special circumstance, including a statement of what action you would like to see taken (additional work study or loan eligibility, and what amount you are willing to borrow)
- A signed copy of the student's and parents' (or your spouse's, if married) 2019 and 2020 federal tax return and W-2s.

Appeal Conditions (check all that apply)

Expenses incurred and/or economic hardship as a result of COVID-19.

Involuntary loss or significant reduction of income and/or benefits

- o Termination/severance letter
- o Final earnings statement from the previous employer
- o Unemployment documentation (including the Maximum Benefits Available)

Significant medical or dental expenses not covered by insurance for family members in the FAFSA household

NOTE: Expenses incurred but not paid do not qualify for consideration

- o Copies of billing statements from the medical or dental provider(s) and proof of payment OR a copy of the 2019 Federal Income Tax Return Schedule A (preferred in lieu of receipts or checks)
- o Expenses paid that are not reported on the Federal Income Tax Return Schedule A

One-time income received in 2019 that will not be received in 2020 and/or 2021 (severance, child support, etc.)

- o Document the final payment and total amount received in 2020 and/or 2021

Death of a parent or spouse

- o Copy of the death certificate

Divorce or separation after the FAFSA was filed

- o Copy of legal separation/divorce agreement (court-issued or letter from attorney)
- o Proof of separate addresses (i.e. utility bills)

Parent or additional family member in college

- o Copy of the course registration and charges for tuition, fees, books and required supplies

Exceptional expenses

- o The standard budget reflects the average cost of tuition and fees, books and supplies, living costs, and personal and incidental expenses, including a transportation allowance. Only extraordinary educational expenses that occur during the academic year and substantially exceed those allowed in the standard budget are considered.
- o Examples of expenses that may be considered are computer purchase (once per college enrollment), musical instrument purchase (majors only), costs associated with disability (not covered by insurance or another agency), or books & supplies in excess of allowance. Receipts or purchase invoices are required.
